「2024 青年創作工作室—身體感測」甄選辦法

臺中國家歌劇院(簡稱歌劇院)致力於推動科技於表演藝術創作之應用,以及跨領域藝術之探索與 共創合作,自 2020 年起策劃「LABX 藝術跨域實驗平台」(簡稱「LABX計畫」),深化表演藝術與科技 藝術之交流,期望在全球急速前進與轉變的數位紀元中,支持具前瞻視野之創作者,並持續與國內外多 元領域專業領航者們接軌,從資源整合逐步建立國內跨域人才孵育機制,與藝術創作者們一同探索多元 藝術發展的未來。

以孵育青年創作人才為目標的「青年創作工作室」(簡稱本計畫)·著重於創作想法實踐之研究過程、 討論辯證與階段成果分享·為30歲以下之青年藝術創作者提供專業學習、研究與實驗的機會。2024年 以「身體感測」及「擴增實境」跨域創作為主題、「身體感測」邀請財團法人數位藝術基金會藝術總監王 柏偉及國立清華大學藝術學院學士班暨科技藝術研究所助理教授蔡遵弘擔任雙導師·希冀協助青年創作 者透過經驗傳承、陪伴引導、實務研究方法等不同方式,提高更具前瞻的藝術視野、思想與行動力。

1、申請資格

- (一) 30 歲(含)以下,以臺灣為創作基地,具備2年以上的創作經歷或技術背景。
- (二)以「表演藝術」類別及「身體感測」技術運用做為核心之創作者。
- (三)可以獨立或以共同創作方式參與甄選,共同創作者皆需符合第一點資格。
- (四)獨立或共同創作者需熟稔如 Unity, Unreal, TouchDesigner, Processing, Max/MSP, PureData 等軟體操作·並對 AI 視覺辨識模型(如 Mediapipe, YOLO)。感測器及控制晶片(如 Arduino, Raspberry Pi, Kinect)有基礎認識者尤佳。(請於附件三提供過往案例相關資料·如有影音資料尤佳。)

2、 計畫內容

- (一) 甄選名額:至多2組,可從缺。
- (二) 年度導師: 王柏偉、蔡遵弘。
- (三) 創作主題:以身體的擴延作為想像基礎·如偵測人體內部生理訊號(心跳、皮膚導電度、腦波等)或人體外部之骨架·透過動作捕捉轉化方式·作為創作元素的表演內容設計。
- [四] 創作取材:以《科學怪人》、《聊齋志異》文本擇一·作為創作發展文本的基礎·探求文本內容 與技術應用的邏輯性與豐富度。
- (五) 工作期間:入選者需全程參與並配合以下活動:
 - 1. 導師工作坊: 2024年(以下同)6月17日(一)至6月19日(三)於歌劇院辦理。
 - 2. 創作討論:7月至11月期間·每月於數位基金會與導師進行至少1次實體討論會議·由導師給予回饋。
 - 3. 階段測試:10月23日(三)至10月27日(日),於歌劇院進行。
 - 4. 成果分享會:11月23日(六)於歌劇院角落沙龍舉行·每組20分鐘·含簡報及實驗成果示範呈現。
 - 5. 其他:本計畫相關宣傳與交流活動。

(六) 計畫資源:

- 1. 研創補助:每組新臺幣 15 萬元整(含稅),含各項工作所需之費用。
- 2. 場地空間:
 - (1) 歌劇院提供排練及測試空間、導師工作坊、階段測試及成果分享會場地。
 - (2) 創作討論場地由數位基金會提供,場地借用採預約制。
- 3. 技術設備:電腦(規格:RTX 3070以上)兩組及光學式動作捕捉設備(規格型號:Optitrack) 一組;設備借用採預約制,僅限於歌劇院及數位基金會場地內使用。
- 4. 專業連結:
 - (1) 歌劇院及導師將依實際需求,安排相關專業技能講師工作坊及國內專業機構之參訪。
 - (2) 成果分享會將邀請策展人、創作者、專家學者、評論人、場館與組織相關人員觀看· 並安排會後交流,以建立專業網絡,及獲得進階發展支持的可能性。

4、 評選方式

由歌劇院指定評選委員與年度導師組成評選委員會。

Guide to the Selection Process of 2024 The Young Artist's Atelier Body Sensing Program

National Taichung Theater (NTT) is committed to the application of technology to performing arts as well as the exploration and co-creation of interdisciplinary arts.

NTT launched the LAB *X* Platform in 2020, with the aim to incubate creative talents, the Young Artist's Atelier (referred to as the program) highlights the "research process" of creative ideas and practice and the public presentation of interim results. The fifth edition of the program features creative works of Body Sensing and Augmented Reality (AR). Structured as a mentorship program, the platform functions as an incubation space for professional training, research, and experiment where young artists aged 30 or younger study under prominent guest artists from home and abroad.

The mentors of the 2024 Body Sensing program are WANG Po-wei, artistic director of the Digital Art Foundation (DAF), and TSAI Tsun-hung, technical director of the DAF. By experience sharing, guidance every step of the way, practical research methodology and intensive exchange for trend insight, young artists will be able to expand their artistic horizon, thinking and agency.

I. Applicant eligibility

- 1. Aged 30 or under, based in Taiwan, with more than 2 years of creative work experience or technical background.
- 2. Artist whose work focuses on combining self-selected art form with Body Sensing technologies.
- 3. Proficient in the operation of software such as Unity, Unreal, TouchDesigner, Processing, Max/MSP, PureData, etc. Basic knowledge of AI visual recognition models (ex. Mediapipe and YOLO), sensors, and control chips (ex. Arduino, Raspberry Pi, and Kinect) is preferred. (Please provide relevant information includes audio and video materials on previous works or projects.)

II. About the program

- 1. Number of selected candidates: a maximum of two groups
- 2. 2024 program mentors: WANG Po-wei, TSAI Tsun-hung
- 3. Theme: using augmented body as an idea, incorporating elements such as detecting physiological signals within the body (heart rate, skin conductance, brain waves, etc.) or external skeletal structure and motion capture transformation as creative elements.
- 4. Creation Material: choosing *Frankenstein* by Mary Shelley or *Strange Stories from a Chinese Studio* as the base of creation development.
- 5. Work Period: selected candidates are required to participate in and comply with all the following activities.
 - (1) Creative workshop: a 3-day workshop from June 17 (Mon) to June 19 (Wed), 2024 in the Corner Salon of NTT.
 - (2) Mentoring meetings: from July to November, there will be at least one in-person discussion meeting per month between the candidates and mentors at the DAF. During these sessions, mentors will provide feedback on the creative process.

- (3) Tryout: October 23 (Wed) and October 27 (Sun), 2024.
- (4) Final presentation will be held in the Corner Salon of NTT on November 23 (Sat), 2024.
- 6. Program resources:
 - (1) Grant for research and creative work: NT\$150,000 for each group (tax included), covering the various expenses required for the Program.
 - (2) Venue:
 - NTT will provide the venue for lectures, workshops, tryout and final presentation.
 - DAF will provide the venue for the mentoring meetings and testing.
 - (3) Technical equipment: two sets of computers (RTX 3070) and one set of optical motion capture equipment (Optitrack) will be provided, by reservation in advance. Only for use in the NTT and DFA.
 - (4) Professional connection:
 - NTT and the mentors will arrange professional workshops and visit professional institutions based on actual needs.
 - The presentation event will invite curators, creators, experts, critics, and relevant personnel from venues and organizations to attend. A post-event exchange will be arranged to establish a professional network and explore possibilities for support in the second stage of creations.

III. How to apply

- 1. Submission period: from now until March 28 (Thu.) at 12:00.
- 2. How to apply:

 - (2) The application form requires the following information:
 - A front and back electronic copy of the applicant's ID card or ROC (Taiwan) Resident Certificate.
 - Applicants should upload application forms and supporting materials to a cloud drive and provide a URL link for download.

IV. Assessment and Evaluation

The selection committee is formed by members appointed by NTT and the annual mentors.

- 1. Phase 1: Document review
 - (1) The review criteria includes the completeness of the application materials, the completeness of the proposal, and the originality and feasibility of the work, etc.
 - (2) Review results will be notified by email before April 12 (Fri), 2024.

- 2. Phase 2: On-site interview
 - (1) An interview will be held at NTT on April 25 (Thu), 2024.
 - (2) Selected candidates will be notified separately with details and requirement for the interview.
- 3. The final selection result will be announced on the NTT official website by May 3 (Fri), 2024 via the following route: "NTT+" → "LAB X Platform" → "The Young Artist's Atelier." The selected candidates will also be notified individually by email and phone.
- 4. If there are no suitable candidates for this program by selection committee, it may remain unfilled.

V. Notice

- 1. If the same proposal receives support from other organizations, its presentation should not take place before November 23 (Sat), 2024.
- 2. Incomplete application materials, late submission and unqualified applicant will not be reviewed.
- 3. Applicants under the age of 18 should provide an electronic scan of the print letter of consent signed by the statutory agent or guardian.
- 4. The applicant should warrant that the whole or part of the proposal for this program and the related audio-visual, text and other materials provided do not infringe intellectual property rights of others, such as copyright. The applicant shall be responsible for any violation of the law or infringing the rights of NTT.
- 5. NTT owns the copyright on the photographs, videos and other related documentation materials made during the process of this program, and retains the right to use these materials for purposes including but not limited to public broadcasting, marketing and publicity, CDs, posters or publication.
- 6. Taxes payable on the funding will be withheld by NTT in accordance with the Income Tax Act and other applicable regulations of the Republic of China.
- 7. The selected candidates shall sign agreement with NTT on the implementation, funding and expense write-off of the program. The rights and obligations of both parties shall be handled in accordance with the contract.
- 8. NTT reserves the right to make changes to the program and the right of final interpretation.
