Guide to the Selection Process of 2024 The Young Artist's Atelier Augmented Reality Program

National Taichung Theater (NTT) is committed to the application of technology to performing arts as well as the exploration and co-creation of interdisciplinary arts.

NTT launched the LAB *X* Platform in 2020, with the aim to incubate creative talents, the Young Artist's Atelier (referred to as the program) highlights the "research process" of creative ideas and practice and the public presentation of interim results. The fifth edition of the program features creative works of Augmented Reality (AR) and Body Sensing. Structured as a mentorship program, the platform functions as an incubation space for professional training, research, and experiment where young artists aged 30 or younger study under prominent guest artists from home and abroad.

The mentors of the 2024 Augmented Reality program are Joris Mathieu, director of Théâtre Nouvelle Génération, Centre dramatique national de Lyon, and Nicolas Boudier, scenographer, device designer, lighting designer and photographer. By experience sharing, guidance every step of the way, practical research methodology and intensive exchange for trend insight, young artists will be able to expand their artistic horizon, thinking and agency.

I. Applicant eligibility

- 1. Aged 30 or under, based in Taiwan, with more than 2 years of creative work experience or technical background.
- 2. Artist whose work focuses on combining self-selected art form with AR technology.
- 3. The program (including the review and selection stage) will be conducted in English. Participants are required to have conversational-level English proficiency.

II. About the program

- 1. Number of selected candidates: a maximum of two groups
- 2. 2024 program mentors: Joris Mathieu, Nicolas Boudier
- 3. Theme: Theatre provides a time-limited experience, while a museum offers viewers a free and non-time-limited experience. We invite you to combine fragments from one or multiple existing texts to set the scene based on the transition between theatre (performing arts) and museum (visual arts) and the difference of their indoor spaces and perception of time for your story.

To accentuate the transition between these realms and highlight the transformation and connection of space and the sense of time, augmented reality (AR) technology is recommended. This technology not only expands the perception of space but also integrates the theatrical elements of the performance with the visual arts of the museum, creating a unique blended experience. It's a creative experiment to explore the potential of augmented reality technology in the realm of artistic experience.

- 4. AR development platforms and devices are not restricted.
- 5. Work Period: selected candidates are required to participate in and comply with all the following activities.

- (1) Creative workshop: a 3-day workshop from June 17 (Mon) to June 19 (Wed), 2024 in the rehearsal room of NTT.
- (2) Mentor's workshop: a 7-day workshop held in Lyon, France from June 29 (Sat) to July 8 (Mon), 2024.
- (3) Mentoring meetings: during the period between May and November, participants are required to present interim results at least once a month through online discussion.
- (4) Final presentation will be held in the rehearsal room of NTT on November 23 (Sat), 2024.
- (5) Other: Project related campaign and exchange programs.
- 6. Project resources:
 - (1) Grant for research and creative work: NT\$150,000 for each group (tax included), covering the various expenses required for the Program.
 - (2) Overseas subsidy: NT\$120,000 for each selected candidate (tax included), covering transportation, accommodation and living expenses for mentor's workshop in Lyon, France . Each group can be subsidized for up to 2 persons.
 - (3) Venue: NTT will provide the venue for rehearsals, the creative workshop, mentor's workshop and final presentation.
 - (4) Professional connection:
 - NTT and the mentors will arrange online exchange and workshops with domestic and international professionals as well as visits to professional institutions in Taiwan.
 - The presentation event will invite curators, creators, experts, critics, and relevant personnel from venues and organizations to attend. A post-event exchange will be arranged to establish a professional network and explore possibilities for support in the second stage of creations.

III. How to apply

- 1. Submission period: from now until March 28 (Thu.) at 12:00.
- 2. How to apply:

 - (2) Documents required and notices:
 - A front and back electronic copy of the applicant's ID card or ROC (Taiwan) Resident Certificate.
 - Some application forms and required documents need to be provided in both Chinese and English.
 - Applicants should upload application forms and supporting materials to a cloud drive and provide a URL link for download.

IV. Assessment and Evaluation

The selection committee is formed by members appointed by NTT and the annual mentors.

- 1. Phase 1: Document review
 - The review criteria includes the completeness of the application materials, the completeness of the proposal, and the originality and feasibility of the work, etc.
 - (2) Review results will be delivered by email before April 12 (Fri), 2024.
- 2. Phase 2: On-site interview
 - (1) An interview will be held at NTT on April 23 (Tue), 2024.
 - (2) Candidates who enter the interview phase will receive additional information about the materials required for the interview along with other notices.
- 3. The final selection result will be announced on the NTT official website by May 3 (Fri), 2024 via the following route: "NTT+" → "LAB X Platform" → "The Young Artist's Atelier." The selected candidates will also be notified individually by email and phone.
- 4. If there are no suitable candidates for this program by selection committee, it may remain unfilled.

V. Notice

- 1. If the same program receives support from other organizations, its presentation should not take place before November 23 (Sat), 2024.
- 2. Incomplete application materials, late submission and unqualified applicant will not be reviewed.
- 3. Applicants under the age of 18 should provide an electronic scan of the print letter of consent signed by the statutory agent or guardian.
- 4. The applicant should warrant that the whole or part of the proposal for this program and the related audio-visual, text and other materials provided do not infringe intellectual property rights of others, such as copyright. The applicant shall be responsible for any violation of the law or infringing the rights of NTT.
- 5. NTT owns the copyright on the photographs, videos and other related documentation materials made during the process of this program, and retains the right to use these materials for purposes including but not limited to public broadcasting, marketing and publicity, CDs, posters or publication.
- 6. Taxes payable on the funding will be withheld by NTT in accordance with the Income Tax Act and other applicable regulations of the Republic of China.
- 7. The selected candidates shall sign agreement with NTT on the implementation, funding and expense write-off of the program. The rights and obligations of both parties shall be handled in accordance with the contract.
- 8. NTT reserves the right to make changes to the program and the right of final interpretation.
