## 「2026 青年創作工作室—延展實境」甄選辦法

臺中國家歌劇院 ( 以下簡稱歌劇院 ) 聚焦探索表演藝術與科技交會的可能性，積極開展跨領域藝術的創新對話。自 2020 年起推動「LAB X 藝術跨域實驗平台」( 以下簡稱 LAB X 計畫 )，串聯國內外資源，打造跨界交流的專業環境，提供創作者實驗與實踐創作概念的機會，並透過國際論壇及科技藝術課程，提供深入交流與啟發靈感的管道。

在 LAB X 計畫的脈絡下，「青年創作工作室」( 簡稱本計畫 ) 專注於培育 30 歲以下青年創作者，鼓勵以實驗精神，專注學習與探索，透過專業導師陪伴，以及歌劇院軟硬體支持，提升創作者專業與跨域合作能力，為長期創作職涯奠定基礎。本計畫每年設定不同創作類型，2026 年以「延展實境」及「舞蹈跨域」為創作核心軸線，「延展實境」由加拿大 PHI 工作室 ( PHI Studio ) 創意工程師托馬斯·阿祖格 ( Thomas Azoug ) 擔任導師，「舞蹈跨域」則邀請安娜琪舞蹈劇場藝術總監謝杰樺及媒體藝術家黃偉軒共同指導，希冀透過創作陪伴，拓展思維，提升青年創作者研究與實作的能量，並激發創作動能，逐步建立前瞻性的藝術觀點。

### 一、申請資格

- (一) 計畫成員皆需 30 歲 ( 含 ) 以下，以臺灣為創作基地，具備 2 年以上藝術相關創作經歷及技術背景之個人或團隊。
- (二) 以「表演藝術」及「延展實境技術應用」做為作品核心之創作者。
- (三) 可獨立或以共同創作方式參與甄選，需具有技術操作之能力。
- (四) 本計畫 ( 含評選階段 ) 以英文進行，需具備英文會話能力。

### 二、計畫內容

- (一) 甄選名額：至多 2 組，可從缺。
- (二) 年度導師：加拿大 PHI 工作室 ( PHI Studio ) 創意工程師—托馬斯·阿祖格 ( Thomas Azoug )。
- (三) 創作主題：主題不限，需以表演藝術結合延展實境技術應用，作為創作元素的表演內容。
- (四) 工作時間：入選者需**全程參與**並配合以下工作時間，無法全程參與將失去入選資格：
  - 1. 導師會議：2026 年 ( 下同 ) 4 月至 11 月，每月與導師進行至少 1 次線上作品討論會議，由導師給予回饋。
  - 2. 培訓暨導師工作坊：7 月 14 日 ( 二 ) 至 7 月 19 日 ( 日 ) 於歌劇院辦理。
  - 3. 階段測試：9 月 16 日 ( 三 ) 至 9 月 20 日 ( 日 ) 於歌劇院進行。
  - 4. 成果分享會：11 月 30 日 ( 一 ) 至 12 月 4 日 ( 五 ) 裝台及彩排、12 月 5 日 ( 六 ) 於歌劇院舉行，每組 20 分鐘，含簡報及實驗成果示範呈現。
  - 5. 本計畫相關宣傳與交流活動。
  - 6. 其他：計畫工作期間，需自備相關軟硬體。
- (五) 計畫資源：
  - 1. 研創補助：每組新臺幣 20 萬元整 ( 含稅 )，含各項工作所需之費用。

2. 場地空間：歌劇院提供排練空間、培訓暨導師工作坊、階段測試及成果分享會場地。
3. 專業連結：
  - (1) 歌劇院及導師將依實際需求，安排相關專業講師工作坊及國內專業機構參訪。
  - (2) 成果分享會將邀請策展人、創作者、專家學者、評論人、場館與組織相關人員參與，並安排會後交流，以建立專業網絡，獲得進階發展支持的可能性。

### 四、評選方式

由歌劇院邀請評選委員與年度導師組成評選委員會。

- (一) 第一階段：書面審查
  1. 審查內容包括申請資料完備、計畫完整度、作品原創性與可行性等。
  2. 審查結果將於 2 月 13 日 ( 五 ) 前，以 E-mail 通知。
- (二) 第二階段：現場面談
  1. 3 月 11 日 ( 三 ) 或 3 月 12 日 ( 四 ) 於歌劇院進行現場面談，面談時間以正式通知為準。
  2. 面談需備資料及注意事項，將另行通知入選者。
  3. 評選結果將於 3 月 25 日 ( 三 ) 前，於歌劇院官網「**NTT+探索學習**」→「**LAB X 藝術跨域實驗平台**」→「**青年創作工作室**」專區公告入選者，並以 E-mail 及電話個別通知。

### 五、重要事項

# **Guide to the Selection Process of 2026 The Young Artists' Atelier Extended Reality Program**

National Taichung Theater (NTT) is dedicated to exploring the convergence between performing arts and technology, actively fostering innovative interdisciplinary artistic dialogues. Since 2020, NTT has launched the “LAB X Arts Interdisciplinary Platform” (hereinafter referred to as LAB X), connecting resources from Taiwan and abroad to create a professional environment for cross-disciplinary exchange. LAB X offers opportunities for creators to experiment with and implement their artistic concepts, while international symposiums and art-tech courses serve as channels for in-depth exchange and creative inspiration.

Within the framework of LAB X, “The Young Artists' Atelier” (hereinafter referred to as the Program) focuses on nurturing creators aged 30 or under. It encourages experimentation, dedicated learning, and exploration. Through mentorship from field experts and comprehensive support in both software and hardware from NTT, the Program aims to enhance participants' professional development and interdisciplinary collaboration capabilities, laying a solid foundation for long-term artistic careers.

Each year, the Program highlights different creative fields. **In 2026, the focus will be on two core themes: Extended Reality (XR) and Interdisciplinary Dance. The mentor for the XR focus is Thomas Azoug, Creative Technologist of PHI Studio in Canada.** For Dance Interdisciplinary, HSIEH Chieh-hua, Artistic Director of Anarchy Dance Theatre, together with media artist HUANG Wei-hsuan will serve as mentors. Through hands-on guidance and creative companionship, the Program aims to broaden perspectives, strengthen the research and practical capabilities of young creators, and stimulate creative momentum, gradually shaping forward-looking artistic viewpoints.

## **I. Applicant eligibility**

1. Aged 30 or under, based in Taiwan, with more than 2 years of creative work experience or technical background.
2. **Artists whose works focus on performing arts and the application of extended reality technologies.**
3. To participate either independently or through collaborative creation, with the ability to operate the required technology.
4. The Program (including the review and selection stage) will be conducted in English. Participants are required to have conversational-level English proficiency.

## **II. About the program**

1. Number of selected candidates: a maximum of two groups. If there are no suitable candidates for the Program by selection committee, it may remain unfilled.
2. 2026 program mentor: Thomas Azoug
3. Theme: open to any topic; the performance must integrate performing arts with extended reality technologies as core creative elements.
4. Work Period: **selected candidates are required to participate in and comply with all the**

#### **following activities.**

- (1) Mentoring meetings: during the period between April and November, 2026, participants are required to present interim results at least once a month through online discussion.
  - (2) Mentor's workshop: a 6-day workshop held at NTT from July 14 (Tue) to July 19 (Sun), 2026.
  - (3) Tryout: September 16 (Wed) to September 20 (Sun), 2026 at NTT.
  - (4) Final presentation will be held at NTT on December 5 (Sat), 2026. Stage setup and rehearsals will take place from November 30 (Mon) to December 4 (Fri), 2026. Each group will have 20 minutes, including presentation and demonstration.
  - (5) Project related campaigns and exchange programs.
  - (6) Other: Selected candidates must provide their own related software and hardware throughout the Program period.
5. Program resources:
- (1) Grant for research and creative work: NT\$200,000 for each group (tax included), covering the various expenses required for the Program.
  - (2) Venue: NTT will provide the venue for rehearsals, the creative workshop, mentor's workshop and final presentation.
  - (3) Professional connection:
    - NTT and the mentors will arrange professional workshops and research trip to institutions based on actual needs.
    - The presentation event will invite curators, creators, experts, critics, and relevant personnel from venues and organizations to attend. A post-event exchange will be arranged to establish a professional network and explore possibilities for support in the second stage of creations.

### **III. How to apply**

1. Submission period: from now until February 8 (Sun), 2026 at 23:59.
2. How to apply:
  - (1) Go to NTT website and find "NTT+" → "LAB X Platform" → "The Young Artists' Atelier" section to download the application package.
  - (2) Documents required and notices:
    - A front and back electronic copy of the applicant's ID card or ROC (Taiwan) Resident Certificate.
    - **Some application forms and required documents need to be provided in both Chinese and English.**
    - Applicants should upload application forms and supporting materials to a cloud drive and provide a URL link for download.

#### **IV. Assessment and Evaluation**

The selection committee is formed by members invited by NTT and the mentors.

1. Phase 1: Document review
  - (1) The review criteria includes the completeness of the application materials, the completeness of the proposal, and the originality and feasibility of the work, etc.
  - (2) Review results will be delivered by email before February 13 (Fri), 2026.
2. Phase 2: On-site interview
  - (1) An interview will be held at NTT on March 11 (Wed) and March 12 (Thu), 2026, subject to official notification.
  - (2) Candidates who enter the interview phase will receive additional information about the materials required for the interview along with other notices.
3. The final selection result will be announced on the NTT official website by March 25 (Wed), 2026 via the following route: "NTT+" → "LAB X Platform" → "The Young Artists' Atelier." The selected candidates will also be notified individually by email and phone.

#### **V. Notice**

1. The applicant should warrant that the whole or part of the proposal for the Program and the related audio-visual, text and other materials provided do not infringe intellectual property rights of others, such as copyright. The applicant shall be responsible for any violation of the law or infringing the rights of NTT.
2. If the same program receives support from other organizations, its presentation should not take place before the final presentation at NTT. Programs found to be in violation will be disqualified.
3. Applicants under the age of 18 should provide an electronic scan of the print letter of consent signed by the statutory agent or guardian.
4. NTT owns the copyright on the photographs, videos and other related documentation materials made during the process of the Program, and retains the right to use these materials for purposes including but not limited to public broadcasting, marketing and publicity, CDs, posters or publication.
5. Taxes payable on the funding will be withheld by NTT in accordance with the Income Tax Act and other applicable regulations of the Republic of China.
6. The selected candidates shall sign agreement with NTT on the implementation, funding and expense write-off of the Program. The rights and obligations of both parties shall be handled in accordance with the contract.
7. NTT reserves the right to make changes to the Program and the right of final interpretation.
